



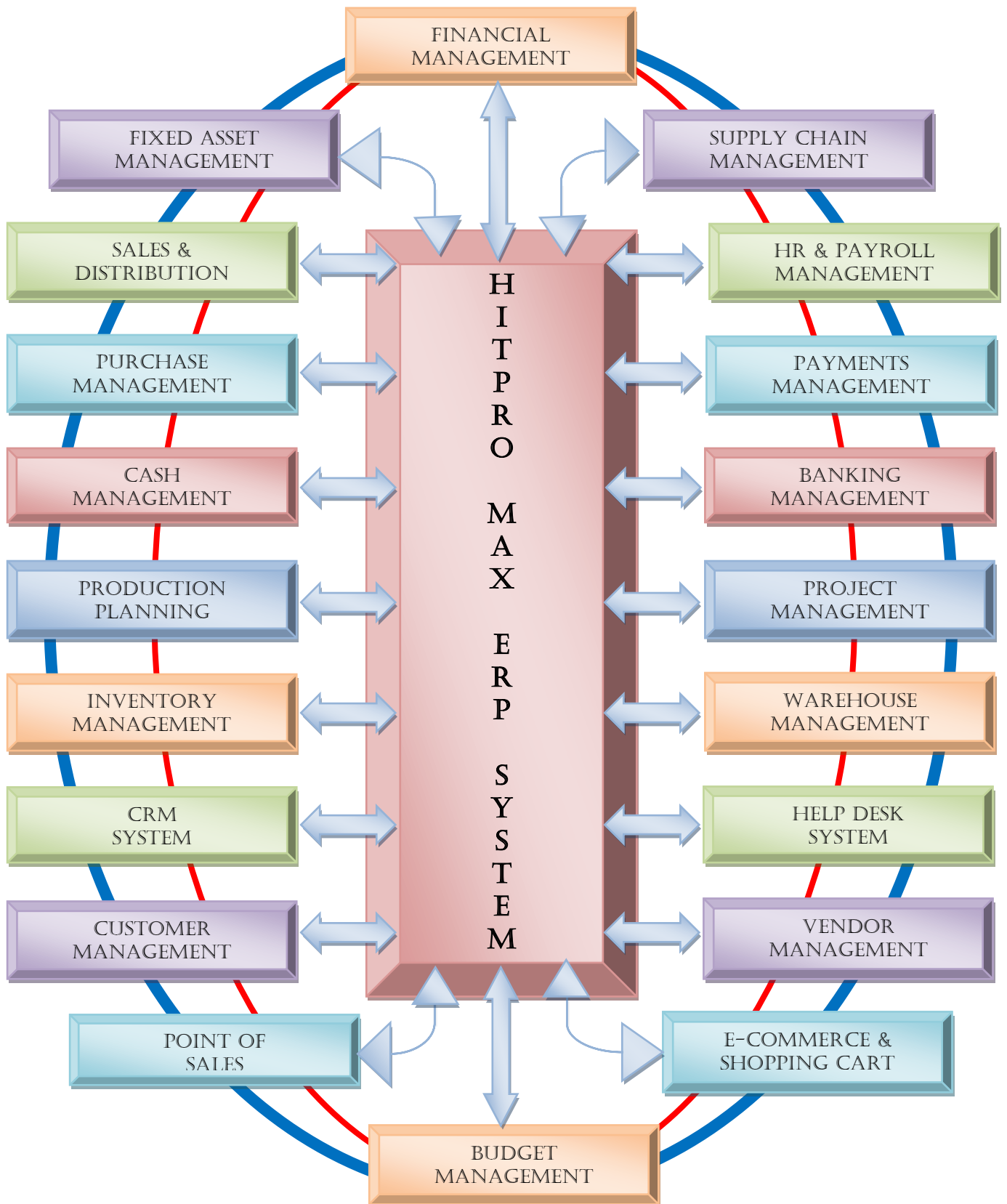

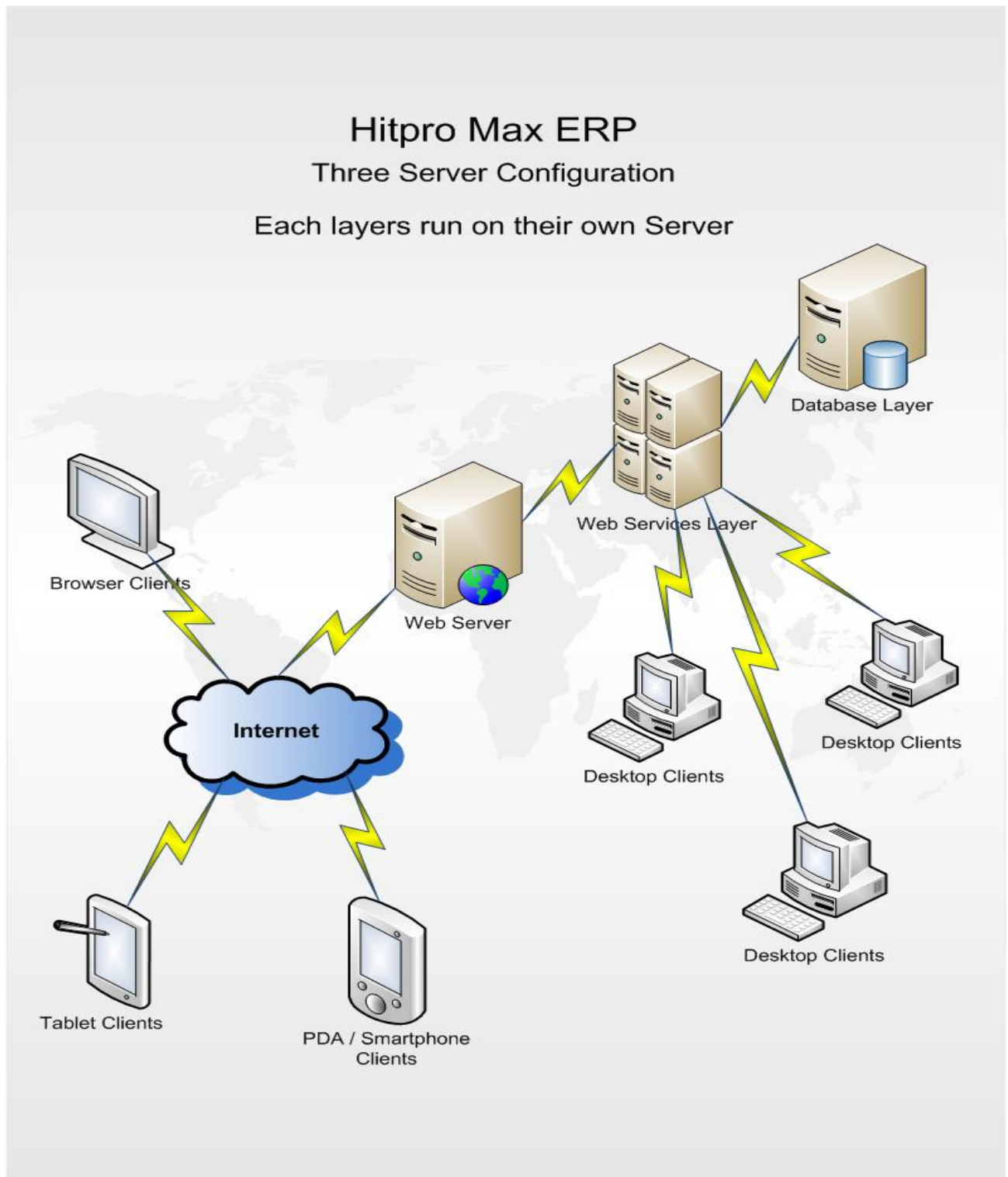
- RUN THE ENTIRE APPLICATION ON ONE SERVER (Single Tier Architecture)

All the system layers like database layer, web services layer and the presentation layer reside in a single web server. This is a kind of single server configuration.



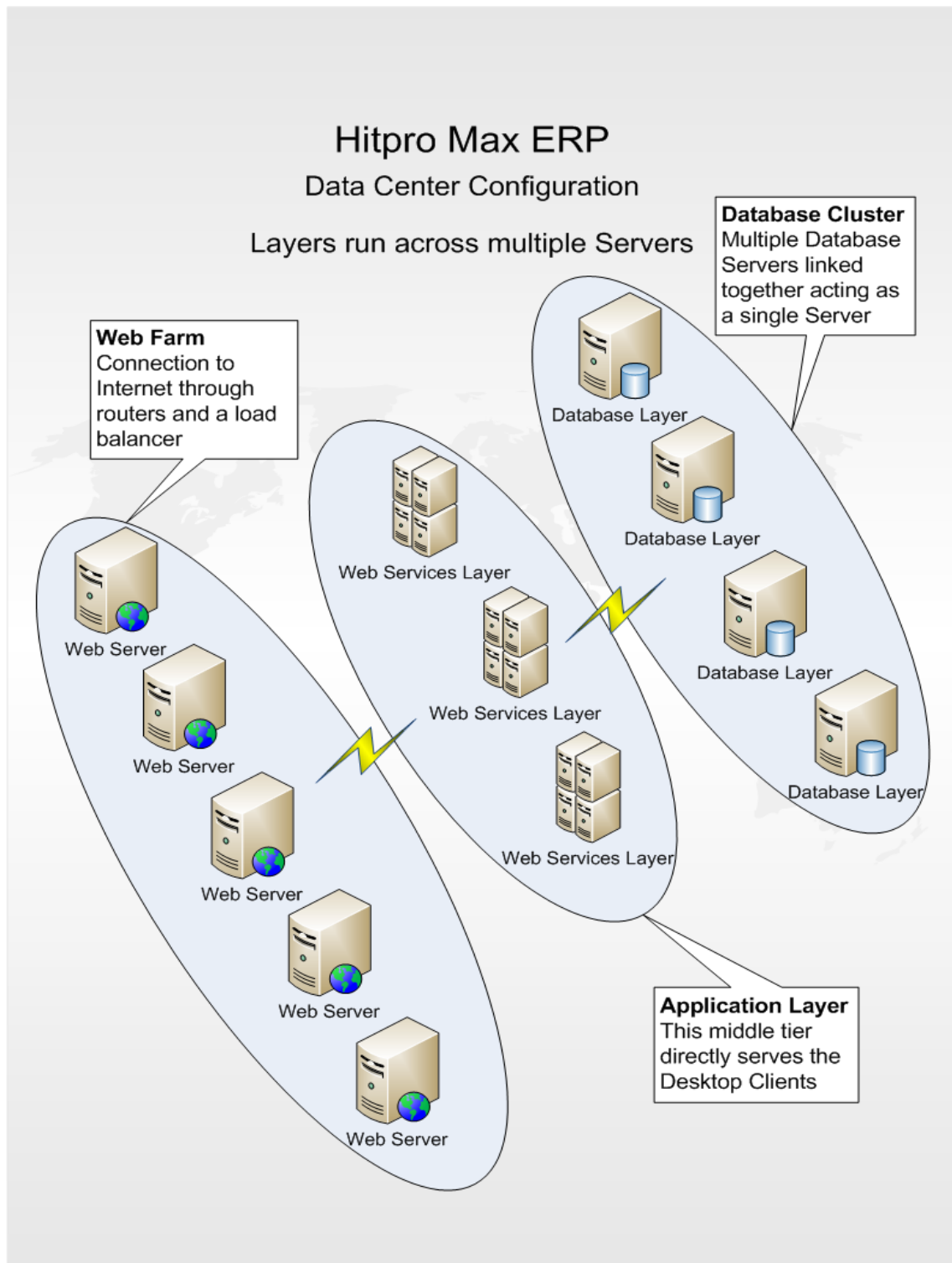
● **RUN EACH LAYER ON ITS OWN SERVER (3 Tier Architecture)**

All the layers reside in different servers. The desktop clients access the system and the data thro the web services layer, where the internet based web clients from a browser or a tablet PC or a PDA and Smartphone devices, access the system and data thro a web server in a similar manner. This is a kind of three tier architecture.



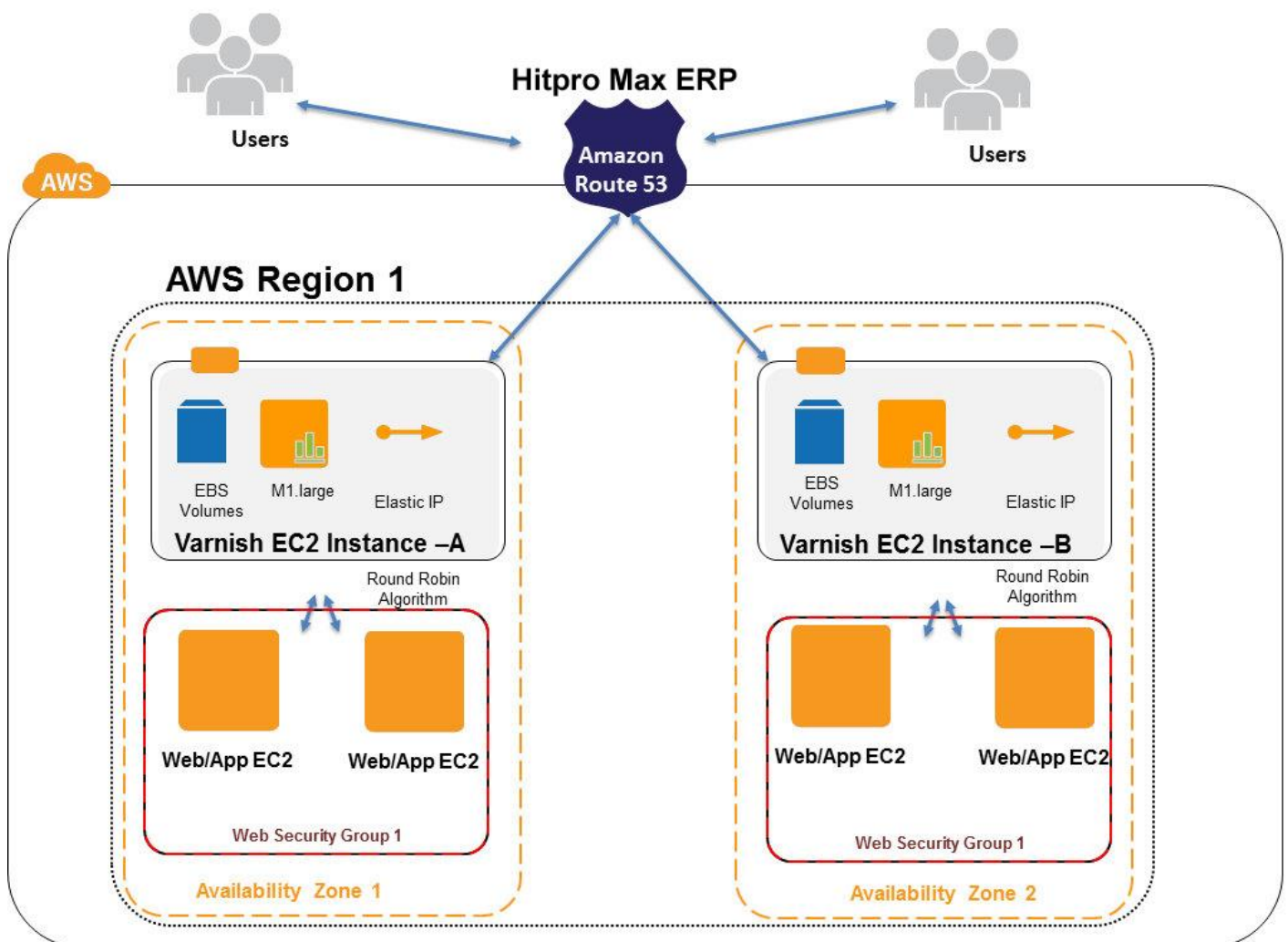
● SPLIT THE APPLICATION ACROSS MULTIPLE SERVERS (n-Tier Architecture)

Each layer runs across multiple servers as per the requirement of a big organization. Here we can see multiple database servers linked together acting as a single server, forming a database cluster. A group of web services layer linked together, forming an application layer, where this middle tier directly serves the desktop clients. And, group of web servers, connecting to internet thro routers and load balancer, forming a web farm. This is a kind of multiple or n-tier architecture.

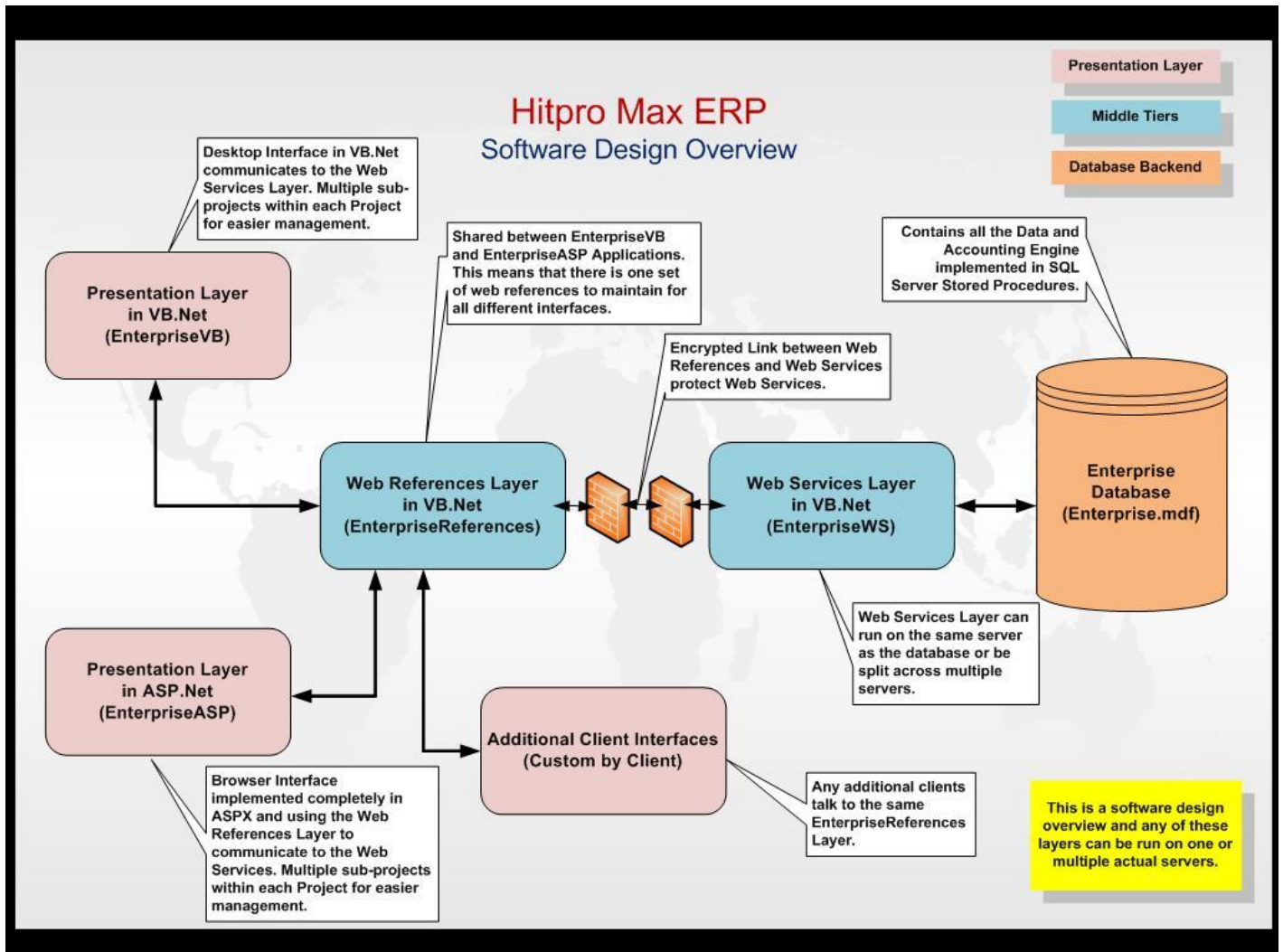


● RUN THE ENTIRE APPLICATION ON A HOSTING SERVER (Cloud Architecture)

Amazon Web Services (AWS) is a cloud-based platform for building business solutions using integrated web services.
